

## Summer Student Job Posting Security - Conservation Areas

We are looking for energetic and responsible students that want to be part of our team connecting people to the environment through outdoor experiences. This is a great opportunity to meet new people, work outside in an inspiring setting and gain valuable work experience.

The student Security position reports to the park superintendent and has the responsibility of assisting with enforcement of policies and regulations within the conservation area. This position provides a great experience if you are looking for a future career in law enforcement.

#### **Responsibilities:**

- 1. To regularly patrol the campgrounds, day-use and satellite areas as required and instructed to ensure public satisfaction and safety.
- 2. Enforce applicable Conservation Area policies and regulations on authority property.
- 3. Respond to complaints and provide good customer service.
- 4. Responsible for daily receipts and night deposits
- 5. Perform grounds and building maintenance such as garbage/recycling collection, washroom cleaning / sanitization etc.
- 6. Secure buildings.
- 7. Keep trucks clean and sanitized.
- 8. Operate shifts at gate and understand park computer system when required.
- 9. Follow GRCA policies and procedures.
- 10. Wear/use all required personal protective equipment (PPE).
- 11. Frequent sanitization of work areas and following GRCA's COVID safe working policies.

### **Qualifications:**

- 1. Must be currently enrolled in post-secondary education in Policing or Enforcement related discipline.
- 2. Must possess a Private Security and Investigative Services Act License.
- 3. Valid First Aid and CPR certification required.
- 4. Familiarity with the Grand River Conservation Authority and park policies.
- 5. Excellent communication and interpersonal skills.
- 6. Ability to keep accurate records.
- 7. Must possess a valid Ontario G or G2 Driver's license.
- 8. Must be able to work weekends, night shifts and holidays (mandatory)
- 9. Ability to work with minimum supervision.

All successful applicants must possess their own Green Patch CSA approved safety boots, be able to work outdoors in all weather conditions and be available to work the duration of the season, 40 hours per week. The GRCA offers comprehensive health and safety training.
